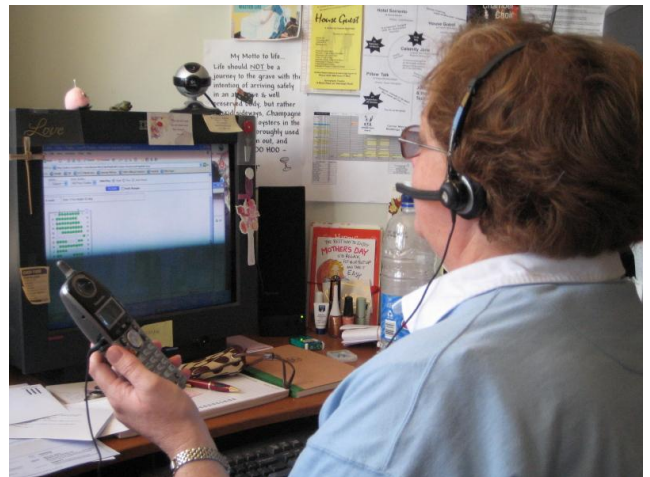

# Appendix 1: Vision Forum

Tuesday, July 10: 2007

## Sunnybank Theatre Group Inc

Following successes in the last few years at Sunnybank Theatre, it was agreed by the present committee to review current strategy and make some precise plans for the next five years or more. In the last few years the theatre has produced many sell-out performances of a very high standard. This year alone, we have seen the introduction of an automated ticketing system and many improvements around the theatre facility. In 2007, members elected a group of very forward thinking participants eager to guide the theatre into the next phase of growth and development.

Members and interested parties were invited to an open forum to discuss ideas to become part of a working strategic plan.

**Purpose of a strategic plan** – The committee agreed that to remain progressive in the development of the theatre, it was important to make documented plans that were a result of a consultative process between management committee and members. A detailed strategic plan would form the framework for current committee, and committees in the future.

As a result of some financially sound management a 'healthy' bank balance exists. The committee is eager to make improvements on the theatre but only after consideration of the 5 year plan. It is a waste of resources to spend money in areas that may not be relevant in a few years time, or may not exist because a wall is moved or something has been re-arranged.

There are some great funding opportunities available through Federal, State, and Local governments. Whilst there is much competition to gain funding dollars, there are definitely more opportunities available to organisations demonstrating strong management and good forward planning.

**Format** – The format of the forum was relaxed and open. Facilitated by Brad Rush, it allowed for open feedback from the interested parties that were present on the evening. Every positive idea has been documented and recorded for review by the committee in due course.

The facilitator encouraged feedback and consolidated thoughts into these three main areas:

1. People – including, members, volunteers, management and audience
2. Artistic – including programming and opportunities for directors, writers, actors, lighting/sound etc
3. Facilities – meaning the building, surrounds and equipment
